DOT Maps Due April 19

Since 1995, the South Dakota Department of Transportation (SDDOT) in cooperation with the South Dakota Planning and Development Districts has been collecting city, county, township, road district, tribal, state, and federal roadway information using Global Positioning System (GPS) technology. This information is utilized by the SDDOT

for several purposes including reporting mileage to the Federal Highway Administration and county auditors, as well as creating county and city maps.

On behalf of the SDDOT, First District staff mailed maps to individuals with jurisdiction over roads and asked for assistance in updating any changes in an effort to keep this roadway information current.



We encourage everyone who received a map to return their maps to First District by April 19 even if there have been no changes.

The assistance of county, city and township officials is critical to the accuracy and overall success of the SDDOT public road inventory, and we believe we all benefit through this multi-agency cooperation.

The 2023 legislative session is over and similar to previous years the legislature dealt with legislation that has some level of impact on local units of government. The following is a recap of some of those bills related to planning and economic development.

This year there was really only one bill approved which dealt directly with planning and zoning. **HB 1029** was an Act to revise certain provisions regarding the county zoning and appeals process. **HB 1029** fixed the inconsistency in County Zoning enabling legislation related to voting requirements for approval created by 2020's SB157. **HB 1029** stipulated that Conditional Use Permits shall only be approved by a majority of Board members present and voting (no super majority required). **HB 1029** also refined the life of a conditional use permit which is appealed to court. If a county zoning ordinance provision sets a time limit for commencement or completion of a special permitted use, conditional use, or variance, that "permit life" is tolled to allow commencement within a period of two years following completion of any final legal appeal of the county zoning decision.

There were several other bills that could have had an impact on local zoning decisions. One dealt with regulations regarding political signs (HB 1099) and eight bills relating to eminent domain. Three of the eminent domain bills were withdrawn by the sponsor with the remaining five eminent domain bills and political sign bill being sent to the 41st legislative day (defeated).

The bill that could have the biggest economic impact for small communities was SB 41. This cleanup bill from 2022 will provide \$100 million for an infrastructure revolving loan fund and \$100 million in grant funding for housing infrastructure. 70% of the funding is set aside for towns less than 50,000 population. The funds are to be administered by SDHDA.

Whether it is David Bowie talking about "ch ch ch changes" or Bob Dylan's "The times they are a changing", we are also experiencing change here at the First District. In March, we said goodbye to Economic Development Officer Christina Crouse. Christina spent two years with the District and was instrumental in assisting our members with obtaining a variety of grants and loans for community and economic development projects. We wish her success. Last month we also said hello to Alex Kahnke and Kelli Henricks. I hold high hopes for both Alex and Kelli and I believe they will grow into their respective Economic Development Officer and GIS Specialist careers. Finally, please join us and the Governing Body at our next Board meeting which will be held at 12 p.m. on Thursday, May 4, 2023, at our office in Watertown. Hopefully the snow will be gone by then.

FDALG Welcomes Kelli Henricks


