First District Assisting with USDA Regional Food Business Center

On May 15, 2023 the U.S. Department of Agriculture (USDA) Rural Development State Director for South Dakota Nikki Gronli recognized the North Central USDA Regional Food Business Center, Region Five Development Commission



(RFDC), which will serve North Dakota, South Dakota, and Minnesota. Regional Food Business Centers will provide national coverage coordination, technical assistance, and capacity building to help farmers, ranchers, and other food businesses access new markets and navigate federal, state, and local resources. FDALG will support the Regional Food Centers by providing direct business technical assistance to small- and mid-sized food and farm businesses (producers, processors, aggregators, distributors, and other businesses within the food supply chain) and food value and supply chain coordination. FDALG is currently developing its plan to identify priority areas for technical assistance which will begin in January 2024.

Last September, the FDALG Governing Body approved its updated Comprehensive Economic Development Strategy (CEDS). The CEDS is a plan/strategy which is designed to bring together the public and private sectors within the First District in the creation of an economic roadmap to diversify and strengthen our regional economies. The CEDS analyzes the regional economy and serves as a guide for establishing regional goals and objectives, developing, and implementing a regional plan of action, and identifying investment priorities and funding sources. The CEDS document usually has a shelf life of five years. However, to coordinate the CEDS life cycle of all the State's Planning Districts, the Economic Development Administration (EDA) is directing all the South Dakota's Planning Districts to update their current CEDS by September 2024. Therefore, we will begin the process of updating our five-year CEDS later this fall with a regional development survey. The survey is comprised of four sections. The first section pertains to the needs of the community or county. The second section deals with economic issues. I encourage all to respond to the survey as this will assist Staff and the CEDS Committee in establishing background information and benchmarks for the CEDS update.

In the last newsletter I talked about personnel changes here at the First District. Well, three months later, we continue to, as Kevin Cronin of REO Speedwagon sings, "Roll with the Changes". Our Planner, Payton Carda, left FDALG at the beginning of August. During her tenure, she worked on multiple Pre-Disaster and Hazardous Mitigation Plans and managed Hamlin County Zoning.
